You acknowledge that rodeo events are inherently dangerous activities. You further acknowledge that participation in rodeo events (whether as a competitor, independent contractor, official, laborer, volunteer, or observer) exposes you or your child to substantial and serious hazards and risks of property damage, personal injury and/or death from the unpredictable actions of livestock and other hazards, risks and conditions. In consideration of you or your child being permitted to participate in this Event in any capacity, you, by you or your child's participation in the event, agree to assume such hazards, risks and conditions.

You further agree to discharge, waive, and release, and covenant not to sue all contestants, stock contractors, rodeo committees, rodeo producers, contract personnel, UTAH COUNTY, SPANISH FORK CITY, ROCKING B RODEO and each of the forgoing parties' respective owners, officers, directors, employees, agents, subcontractors, volunteers, heirs, sponsors, and assigns(hereinafter collectively referred to as the Releasees) from any and all claims, demands and liabilities for any and all property damage, personal injury and /or death to you or your child arising from such Releasees' participation in, and any and all occurrences related in any manner to, the Event. This discharge, waiver and release includes claims, demands and liabilities that are known or unknown, foreseen or unforseen, future or contingent, and includes all claims, demands and liabilities arising out of the negligence of the Releasees. Furthermore, where permitted by applicable law, this discharge, waiver and release also includes claims, demands and liabilities arising out of the gross negligence or willful and wanton negligence of the Releasees. This discharge, wavier and release also includes claims, demands, and liabilities by you or your child for indemnities and contributions arising from property damage, personal injury and/or death to a third party. In the event that any provision of this discharge, waiver and release is determined to be invalid for any reason, such invalidity shall not affect the validity of any of the other provisions, which other provisions shall remain in full force and effect as if this discharge, waiver and release had been executed with the invalid provision eliminated.

The undertakings and covenants of the foregoing provisions shall be binding upon you, your child, your heirs, legal representatives, successors and assigns.

You agree to INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees from any and all claims, demands and liabilities for any and all property damage, personal injury and/or death asserted by a third party and arising from you or your child's participation in the Event.

You further expressly agree that the forgoing Release, Waiver of Liability, and Indemnity Agreement is

intended to be as broad and inclusive as is permitted by the laws of the State of Utah.
